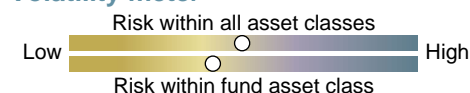

Investment management style

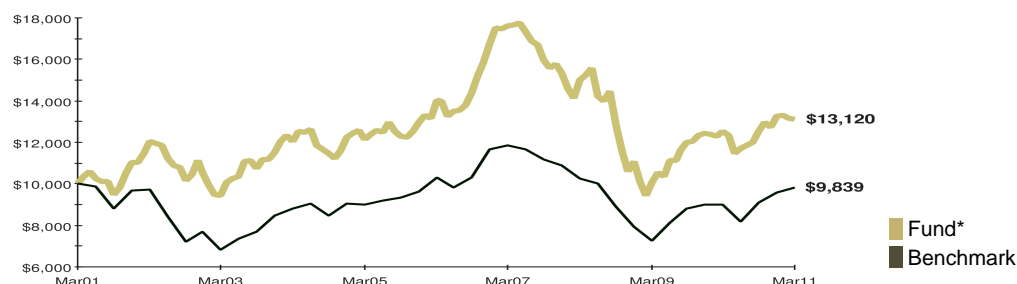

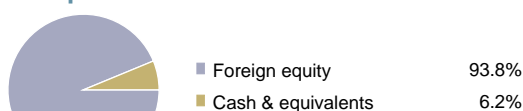

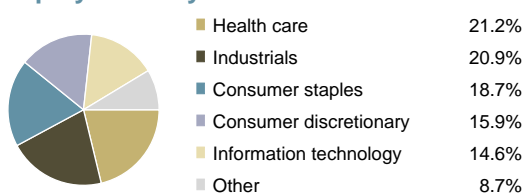

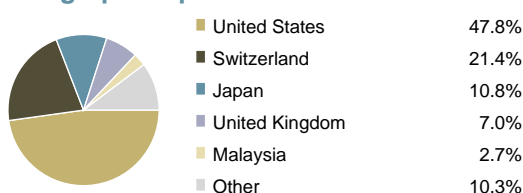
Composition
